

A MESSAGE FROM THE DEPARTMENT OF CONSUMER PROTECTION LIQUOR CONTROL COMMISSION

COMMISSIONER JERRY FARRELL, JR., CHAIRMAN

As you know, a budget for the State of Connecticut was recently adopted. Included in the budget is a provision which mandates an increase in the fees collected by various state agencies, including the Department of Consumer Protection. This provision affects most liquor permits and fees in Connecticut issued and/or renewed on and after October 1, 2009.

The fee schedule, which will be effective October 1, 2009, is for liquor permits and related fees.

Please be advised that a requirement for the issuance of a final liquor permit, if it is issued on or after October 1, 2009, will be the payment of any balance due in accordance with the permit fee increase as mandated by the legislation. This may impact those of you operating with a provisional permit and those who have an application for liquor permit pending with the department.

All fees collected from you are deposited into the State's General Fund and used to fund important programs and services provided by the State of Connecticut.
